



Software Licence

This Software Licence and Warranty is a legal agreement between you (either an individual or an entity) (Licensee) and V7 Technology Ltd (Licensor). By taking delivery of the software package and/or by using the Product and Licensed Software, the Licensee agrees to become bound by the terms of this Software Licence and Warranty Agreement.

1. Definitions

A. Product means the V7 Server Suite, Administrator, Configurator, Author, and Typist programs including any associated Setup and Installation Files and any Installed Files.

B. Licensed Software means the V7 Server Suite, Administrator, Configurator, Author and Typist Executable Programs, the Executable and Setup Programs, Support Files, and any associated documentation.

2. The Software Licence

The Licensor hereby grants to the Licensee a personal non-transferable, non-exclusive, limited license to use the Licensed Software on up to three computers on the following conditions:

A. The Licensee shall not connect to more than one server using the Licensed Software computers without first obtaining a licence from Licensor for each additional server.

B. The Licensee may not modify the Licensed Software, nor merge it with other software, and shall prevent the disclosure of it to any third party, in whole or part, by direct or indirect means.

C. The Licensee may copy the Licensed Software noting that the Licensed Software and any accompanying written materials are protected by United Kingdom copyright laws and international treaty provisions.

D. The Licensee may not modify, adapt, translate, reverse engineer, decompile, disassemble, or create derivative works based on the Licensed Software.

E. The Licensee owns the physical media on which the Licensed Software is recorded or fixed but the Licensor retains all title and ownership of the Licensed Software. Licensor retains all rights not expressly granted to the Licensee.
